<p>Answer: The Company expects reduced levels of net operating cash outflows over the next 2 quarters on the basis that technical studies and development plans at the Fountain Head Gold Project have already been significantly progressed.</p> <p>PNX informed the market that a Non-binding Term Sheet has been agreed with private company Halifax Capital and a joint venture (JV) with its subsidiary Bridge Creek Mining, including a proposed financial commitment of A\$40m to develop the Fountain Head Gold Project (see ASX release dated 15 July 2020).</p>

<p>Answer: The Company intends to raise further capital when required to fund its continuing operations. Historically, the Company has been able to raise funds and receives strong support from its shareholders. Accordingly, the Company expects to be able to raise the required funds.</p>
